UNDERSTANDING THE BIRTHING CENTER SAFETY RATINGS:

The following data has been provided by the The Leapfrog Group, a Washington, D.C. based organization aiming to improve health care quality and safety for consumers and purchasers. An estimated 2,000 hospital participate in Leapfrog's annual survey in order to provide transparency of outcomes to the public. To learn more about The Leapfrog Group go to www.leapfroggroup.org.

Data strongly demonstrates that **EARLY ELECTIVE DELIVERIES**—scheduled cesarean sections or medical inductions performed prior to 39 weeks of gestation without medical necessity—carry risks to both babies and mothers. Early elective deliveries can result in neonatal intensive care unit (NICU) admissions, longer stays and higher costs to both patients and payers. For this measure, a lower rate is more desirable. Leapfrog's target for all hospitals is 5%.

CESAREAN SECTIONS (C-SECTIONS) carry serious risks of infection or blood clots, and many women experience longer recoveries and difficulty with future pregnancies. C-sections can also cause problems for babies, like breathing difficulties that need treatment in a newborn intensive care unit (NICU). To measure a hospital's rate of C-sections, Leapfrog uses one standardized, endorsed measure that reflects the percentage of first-time mothers giving birth to a single baby, at term, in the head-down position. For this measure, a lower rate is more desirable. Leapfrog's target for all hospitals is 23.6%.

An **EPISIOTOMY** is an incision made in the perineum (the birth canal) during childbirth. Although episiotomies were once routine in childbirth, medical guidelines today recommend an episiotomy only in a narrow set of cases. Episiotomies have been clearly linked with worse perineal tears, loss of bladder or bowel control, and pelvic floor defects. For this measure, a lower rate is more desirable. Leapfrog's target for all hospitals is 5%.

SCREEN NEWBORNS FOR JAUNDICE BEFORE DISCHARGE, Hospitals should screen at least 90% of babies for jaundice to achieve the standard.

PREVENTING MATERNAL BLOOD CLOTS, birthing centers and hospitals should give treatment to prevent blood clots at at least 90% of women who undergo a cesarean section to achieve the standard.

HIGH-RISK DELIVERIES occur when infants are born weighing less than 1500 grams (3 pounds, 4.91 ounces), they must be cared for in a NICU with proven capacity to care for them. To achieve Leapfrog's standard, a hospital must deliver at least 50 very-low birth weight babies per year and ensure that at least 90% of mothers receive antenatal steroids prior to delivery OR the hospital must maintain a lower-than-average morbidity/mortality rate for very-low birth weight babies and ensure that at least 90% of mothers receive antenatal steroids prior to delivery.

Hospitals that did not participate in the Leapfrog Survey demonstrate resistance to being transparent about their outcomes with the public and are marked with an "X." Research shows hospitals who participate in transparency improve in patient safety and quality of care.
